The following is a summary of the legislative and other matters to come before the Wilsonville City Council a regular session to be held, March 17, 2025 at City Hall. Legislative matters must have been filed in the office of the City Recorder by 10:00 a.m. on March 4, 2025. Remonstrances and other documents pertaining to any matters listed in said summary filed at or prior to the time of the meeting may be considered there with except where a time limit for filing has been fixed.

GOOD EVENING, EVERYONE. AND FOR THOSE THAT CELEBRATE HAPPY SAINT PATRICKS DAY.

CITY COUNCIL RETREAT

FIRST, I WOULD LIKE TO TAKE A MOMENT TO REVIEW SOME HIGHLIGHTS FROM THE CITY COUNCIL RETREAT AND GOALSETTING SESSION THAT TOOK PLACE THIS PAST FRIDAY AND SATURDAY MARCH 14 AND 15TH RESPECTFULLY.

EVERY TWO YEARS, AS CITY COUNCIL MEMBERS COME AND GO, THE NEWLY CONSTITUTED CITY COUNCIL TAKES TIME TO REVIEW KEY CITY ISSUES.

BASED ON THIS REVIEW AND THE TOPICS THAT ARE OF MOST CONCERN TO EACH CITY COUNCIL MEMBER, THE COUNCIL WORKS WITH A FACILITATOR TO DEVELOP A SET OF SPECIFIC GOALS AND OBJECTIVES FOR THE CITY TO ACCOMPLISH OVER THE NEXT TWO YEARS. AS PART OF THE PROCESS, CITY STAFF LEADERSHIP FROM ALL CITY DEPARTMENTS PROVIDES CRITICAL INFORMATION TO THE COUNCIL TO ENABLE EFFECTIVE DECISION-MAKING.

BASED ON THIS WEEKEND'S RETREAT AND GOAL-SETTING
SESSION, I HAVE SOME PERSONAL OBSERVATIONS TO SHARE.
LATER IN THIS MEETING, COUNCILORS WILL SHARE THEIR
OWN PERSPECTIVES.

TO BEGIN, COUNCIL SPENT CONSIDERABLE TIME CONSIDERING THE EXISTING CONTEXT AND CLIMATE, INCLUDING:

- CURRENT POLITICAL FACTORS AT THE FEDERAL, STATE, AND LOCAL LEVELS.
- THE FINANCIAL CLIMATE GIVEN UNCERTAINTIES AT THE STATE AND FEDERAL LEVEL CONCERNING FUNDING.
- TECHNOLOGY FACTORS
- CUSTOMER NEEDS.
- UNCERTAINTIES RELATED TO THE GLOBAL ECONOMY
- COST OF CONSTRUCTION, AND SUPPLY CHAIN CHALLENGES
- WE ALSO DISCUSSED KEY STAFF DEPARTURES THAT WILL OCCUR IN 2025, INCLUDING THE GOVERNMENT AND PUBLIC AFFAIRS DIRECTOR (MARK OTTENAD), COMMUNITY DEVELOPMENT DIRECTOR (CHRIS NEAMTZU), AND CITY MANAGER (BRYAN COSGROVE).
- THE COUNCIL IS AWARE THAT IF THE NEXT CITY MANAGER IS AN EXTERNAL CANDIDATE, THEY WILL NEED TIME AND GRACE TO GET UP TO SPEED AND ESTABLISH RELATIONSHIPS WITH THE COUNCIL AND STAFF. IF THEY ARE AN INTERNAL CANDIDATE, TIME WOULD STILL BE NEEDED FOR THEIR EFFECTIVE TRANSITON INTO THEIR NEW ROLE AND TO FIND SOMEONE TO FILL THEIR PRIOR ROLE IN THE CITY.
- IN SHORT PROGRESS ON COUNCIL GOALS MAY REQUIRE SOME INITIAL PATIENCE.
- THE COUNCIL COALESCED AROUND SOME BROAD THEMES AND IDENTIFIED SPECIFIC GOALS UNDER THESE THEMES.

UNDER THE UMBRELLA OF <u>PUBLIC HEALTH, SAFETY, AND</u> <u>WELFARE</u>, THE COUNCIL IDENTIFIED THE FOLLOWING GOALS:

- STREAMLINE RESPONSE TO CODE ENFORCEMENT CHALLENGES.
- EXPAND ON-THE-GROUND MENTAL HEALTH RESOURCES TO SUPPORT THE COMMUNITY.
- EVALUATE AND UPDATE THE PUBLIC NUISANCE CODE AND EXPLORE A RENTAL INSPECTION PROGRAM, INCLUDING IDENTIFYING POTENTIAL REVENUE STREAMS TO FUND SUCH A PROGRAM.

THE COUNCIL ALSO DISCUSSED THE CURRENT AND FUTURE
FISCAL HEALTH OF THE CITY'S MANY OPERATING FUNDS AND
DEVELOPED SPECIFIC GOALS UNDER THE HEADING OF
FINANCIAL OUTCOMES:

- EXPLORE COST SAVINGS, EFFICIENCIES, AND ALTERNATIVE REVENUE OPTIONS FOR SUSTAINABLE FISCAL HEALTH.
- FUTURE-PROOF REVENUES AND AVOID LARGE RATE SPIKES IN THE SEWER, WATER, AND STORMWATER FUNDS BY INDEXING THESE UTILITIES TO A CIP INDEX.

ADDITIONALLY, THE COUNCIL SPENT A GREAT DEAL OF TIME DISCUSSING WAYS THE CITY CAN BUILD TRUST THROUGH COMMUNICATION AND COMMUNITY ENGAGEMENT. THE FOLLOWING GOALS WERE ESTABLISHED:

 ENGAGE THE COMMUNITY ON URBAN RENEWAL AND OTHER INFRASTRUCTURE FUNDING SOURCES.

- CREATE A TOWN CENTER COMMUNICATION AND ENGAGEMENT STRATEGY TO HELP INFORM COUNCIL DIRECTION.
- EVALUATE AND IMPROVE ONLINE ENGAGEMENT AND SOCIAL MEDIA TOOLS TO EXPAND OUR AUDIENCE AND REACH WITHIN THE COMMUNITY.
- LASTLY, THE COUNCIL ADVANCED A GOAL TO ENSURE THE CURRENT LEVEL OF PARKS MAINTENANCE IS PROVIDED FOR THE LONG TERM. AS THE CITY'S PARKS PORTFOLIO CONTINUES TO GROW, WITH AN ADDITIONAL 30 ACRES OF MAINTENANCE RESPONSIBILITY COMING ONLINE IN THE NEXT 2-3 YEARS.
- IN SHORT THE GOAL IS TO: MAINTAIN EXISTING MAINTENANCE LEVELS OF SERVICE WITH UPCOMING PARKS EXPANSION BY IDENTIFYING ADDITIONAL REVENUE OPPORTUNITIES AND POTENTIAL COST SAVINGS.
- I LOOK FORWARD TO HEARING MY COLLEAGUES' PERSPECTIVES
 LATER IN THE MEETING. I THOUGHT EVERYONE AT THE TABLE
 WORKED EXTREMELY HARD TO FIND WAYS TO MOVE OUR
 CITY FORWARD DURING THESE UNCERTAIN TIMES.

LEGISLATIVE TESTIMONY

NOW, ON TO MY NEXT ITEM TO REPORT ON.

- WORKING WITH CITY STAFF, LEGISLATORS AND COMMUNITY MEMBERS, I HAVE PROVIDED WRITTEN AND ORAL TESTIMONY TO VARIOUS LEGISLATIVE COMMITTEES ON A NUMBER OF BILLS ON TOPICS OF INTEREST TO THE CITY.
- THE CITY COUNCIL'S ADOPTION OF A LEGISLATIVE AGENDA AND SPECIFIC SET OF 2025 LEGISLATIVE PRIORITIES IS VERY HELPFUL IN SCREENING THE HUNDREDS OF BILLS NOW BEING HEARD BY THE OREGON LEGISLATURE.
- TESTIMONY THAT THE CITY HAS SUBMITTED OVER THE PAST FEW WEEKS INCLUDES THE FOLLOWING:
- TESTIMONY IN SUPPORT OF SENATE BILL 179, WHICH RESTORES RECREATIONAL IMMUNITY FOR LANDOWNERS WHO ALLOW FREE PUBLIC ACCESS TO TRAILS AND RECREATIONAL ACTIVITIES.
- THIS IS AN IMPORTANT ISSUE FOR WILSONVILLE RESIDENTS
 AND ALL OREGONIANS WHO ENJOY WALKING, HIKING AND
 RECREATING ON TRAILS AND AREAS OPEN TO THE PUBLIC.
- **TESTIMONY SUPPORTING AN AMENDED HOUSE BILL 3031-1.**
- HERE, THE CITY URGED AN ENLARGED SCOPE OF RESIDENTIAL INFRASTRUCTURE RESOURCES THAT COULD SUBSTANTIALLY ADVANCE STATE GOAL FOR HOUSING PRODUCTION.

- THIS IS THE GOVERNOR'S OFFICE HOUSING INFRASTRUCTURE FINANCING BILL, WHICH IS TOO LIMITED IN SCOPE AND FUNDING.
- IN PARTICULAR, WE ADVOCATED FOR FUNDING OF OFF-SITE INFRASTRUCTURE IMPROVEMENTS, SUCH AS WILSONVILLE'S \$18 MILLION BOECKMAN ROAD SEWER-INTERCEPTOR PROJECT TO SERVE HOUSING PROPOSED FOR THE NEW URBAN GROWTH AREAS OF FROG POND.
- RELATED, WE ALSO RECOMMEND DEVELOPING DIFFERENT
 STANDARDS FOR INFILL AND SMALL PROJECTS VERSUS
 LARGE URBAN GROWTH AREAS, SUCH AS FROG POND, THAT
 HAVE NO EXISTING INFRASTRUCTURE.

TESTIMONY SUPPORTING HOUSE BILL 3560.

- THIS PROPOSED LEGISLATION ADDRESSES CRITICAL NEED TO IMPROVE CHILD CARE AVAILABILITY THAT BENEFITS BOTH WORKING FAMILIES AND EMPLOYERS.
- FOR YEARS, WILSONVILLE HAS HEARD FROM FAMILIES, EMPLOYERS, AND EMPLOYEES ABOUT THE SHORTAGE OF CHILD CARE OPTIONS, WHICH LIMITS WORKFORCE PARTICIPATION AND HINDERS BUSINESSES' ABILITY TO RECRUIT AND RETAIN EMPLOYEES.

TESTIMONY IN SUPPORT OF HOUSE BILL 2679.

SPONSORED BY REPRESENTATIVE COURTNEY NERON, THIS PROPOSED LEGISLATION RESTRICTS THE USE OF PRODUCTS

CONTAINING POWERFUL CLASS OF NEONICOTINOID
PESTICIDES SHOWN TO BE HARMFUL TO POLLINATORS AND
THE AGRICULTURAL INDUSTRY.

- IN JUNE 2013 WILSONVILLE WAS THE SITE ON PRIVATE PROPERTY OF REPORTEDLY THE LARGEST POLLINATOR BUMBLE BEE-KILL IN THE HISTORY OF THE US, A DISTINCTION THAT OUR COMMUNITY DOES NOT RELISH.
- AND THIS WAS ALL DUE TO THE APPLICATION OF NEONICOTINOID PESTICIDES BY TRAINED PROFESSIONAL APPLICATORS.
- THIS POWERFUL CLASS OF PESTICIDES HAS BEEN SHOWN CONCLUSIVELY TO HARM POLLINATORS THROUGHOUT THE LIFE-CYCLE OF THE PRODUCT, WITH DETRIMENTAL EFFECTS CONTINUING LONG AFTER INITIAL TREATMENT SINCE PLANTS TAKE-UP THE PESTICIDE INTO THEIR TISSUES.
- TESTIMONY SUPPORTING AN AMENDED VERSION OF HOUSE BILL 2138-1.
- THIS BILL IS ONE THAT WAS NOT READY FOR PRIME TIME.
- THIS BILL CONTAINS AMBIGUOUS PHRASES AND LACK OF CLARITY IN SOME SECTIONS OF THAT MAY RESULT IN UNINTENDED CONSEQUENCES DETRIMENTAL TO THE STATE GOAL OF INCREASED MIDDLE-HOUSING PRODUCTION.
- THE CITY'S PROPOSED AMENDMENTS TO HB 2138-1 WOULD PROVIDE GREATER CLARITY AND REMOVE UNCERTAINTY THAT ALLOWS LOCAL GOVERNMENTS AND DEVELOPERS TO

FOCUS ON PRODUCING MORE MIDDLE-HOUSING RESIDENTIAL DEVELOPMENT.

TESTIMONY IN SUPPORT OF HOUSE 3503.

- THIS BILL WOULD SUPPORT AN INNOVATIVE HOUSING PLAN BY CLACKAMAS COUNTY THAT PROVIDES AN OPPORTUNITY FOR OLDER HOMES TO BE ACQUIRED BY LOWER-INCOME RESIDENTS WHO CAN BECOME HOMEOWNERS.
- CLACKAMAS COUNTY SEEKS TO SELL OVER 140 OLDER HOMES WITH HIGH MAINTENANCE COSTS FROM A PORTFOLIO KNOWN AS "SCATTERED SITES."
- DUE TO DISINVESTMENT OVER TIME BY THE US DEPARTMENT HOUSING AND URBAN DEVELOPMENT (HUD), THIS KIND OF VOUCHER-SUPPORTED HOUSING IS NO LONGER BEING SUBSIDIZED.
- TESTIMONY SUPPORTING HOUSE BILL 3700 THAT ADDRESSES THE PRESSING ISSUE OF A LACK OF TRAINED WATER AND WASTEWATER OPERATORS.
- THE BILL WOULD CREATE A STATE PROGRAM TO CERTIFY QUALIFIED OUT-OF-STATE OPERATORS OF WATER AND WASTEWATER SYSTEMS.
- AND IN A SIMILAR MANNER, THE CITY SUPPORTS SENATE BILL 1086.
- THIS LEGISLATION PROVIDES FOR STATE AGENCIES'
 COLLABORATION TO INCREASE THE NUMBER OF QUALIFIED

- BUILDING INSPECTORS WHO CAN HELP WITH HOUSING PRODUCTION.
- BUILDING INSPECTORS ARE NEEDED TO REVIEW, INSPECT, AND APPROVE ALL NEW HOUSING PROJECTS IN OREGON.
- IN ORDER TO ADVANCE HOUSING PRODUCTION ON A TIMELY BASIS, LOCAL JURISDICTIONS NEED ACCESS TO A READY SUPPLY OF BUILDING INSPECTORS WHO ARE ABLE TO COMPETENTLY INSPECT NEW DWELLINGS UNDER CONSTRUCTION PRIOR TO OCCUPATION IN ORDER TO ENSURE PUBLIC SAFETY.
- AND FINALLY, I PERSONALLY TESTIFIED IN SUPPORT OF HOUSE BILL 3453.
- THIS BIPARTISAN LEGISLATION IS CO-SPONSORED BY
 REPRESENTATIVE KEVIN MANNIX OF NORTH SALEM AND
 KEIZER, A REPUBLICAN, AND BY OUR REPRESENTATIVE
 COURTNEY NERON, A DEMOCRAT FROM WILSONVILLE.
- THE BILL CREATES THE WESTSIDE EXPRESS SERVICE AUTHORITY TO ASSUME OPERATIONAL RESPONSIBILITY OF WES, OR THE WESTSIDE EXPRESS SERVICE COMMUTER TRAIN, FROM TRIMET.
- HB 3453 PROVIDES THE OPPORTUNITY TO IMPROVE I-5
 COMMUTING AND MOBILITY OPTIONS BETWEEN THE
 PORTLAND METRO AREA AND THE NORTH WILLAMETTE
 VALLEY SALEM/KEIZER METRO AREA WITH A RELIABLE HIGHCAPACITY PUBLIC-TRANSIT ALTERNATIVE.

THE PRIMARY REASON THAT WES HAS FAILED TO LIVE-UP TO RIDERSHIP TARGETS IS THAT WES CURRENTLY ONLY OPERATES WITH A LIMITED SCHEDULE AND ACTS ONLY AS INTER-CITY SUBURBAN CONNECTOR FOR BEAVERTON, TIGARD, TUALATIN AND WILSONVILLE.

CONNECTING THE GREATER PORTLAND AND SALEM/KEIZER METRO AREAS OFFERS THE OPPORTUNITY TO GREATLY ENHANCE RIDERSHIP AND SUPPORTING REVENUE GENERATION.

MEETINGS

OVER THE PAST MONTH, I HAVE PARTICIPATED IN A NUMBER OF MEETINGS WITH LOCAL AREA ELECTED OFFICIALS AND COMMUNITY MEMBERS.

I RECENTLY PARTICIPATED IN AN HOUR-LONG MEETING WITH CONGRESSWOMAN ANDREA SALINAS, REPRESENTATIVE NERON, METRO COUNCILOR CHRISTINE LEWIS, OREGON DEPARTMENT OF TRANSPORTATION (ODOT) DIRECTOR KRIS STRICKLER, ALONG WITH STAFF FROM THE ELECTED OFFICIALS, ODOT, AND THE CITY.

- THE PURPOSE OF THIS MEETING WAS TO RECEIVE AN UPDATE FROM ODOT ON THE CURRENT STATUS OF THE I-5 BOONE BRIDGE SEISMIC REPLACEMENT PROJECT AND DISCUSS POTENTIAL NEXT STEPS.
- UNFORTUNATELY, ODOT DOES NOT HAVE A FUNDING PLAN FOR THE NEXT PHASE OF WORK, WHICH IS

ESTIMATED TO COST BETWEEN \$3 TO \$5 MILLION, AND POTENTIALLY AS MUCH AS \$7 TO \$8 MILLION. EVEN MORE CONCERNING IS THAT THE COSTS TO REACH THE FINAL DESIGN ARE EXPECTED TO BE IN THE TENS OF MILLIONS OF DOLLARS, AND THIS DOES NOT EVEN INCLUDE CONSTRUCTION COSTS, WHICH COULD EASILY EXCEED \$1 BILLION.

- WE NEED TO APPROACH THIS MASSIVE PROJECT STEP BY STEP, MUCH LIKE TACKLING ANY LARGE CHALLENGE. REALISTICALLY, GIVEN THE INCREASING DYSFUNCTION OF THE FEDERAL GOVERNMENT UNDER THE NEW ADMINISTRATION AND THE UNILATERAL RESCINDING OF CONGRESSIONALLY APPROVED FUNDING, WE ARE UNCERTAIN ABOUT THE LEVEL OF SUPPORT WE CAN EXPECT FROM OUR FEDERAL PARTNERS. THE STATE, WHICH RELIES ON FEDERAL FUNDS FOR PORTIONS OF OREGON'S BUDGET, IS ALSO IN A POTENTIALLY PRECARIOUS POSITION.
- NONETHELESS, ODOT HAS PROVIDED US WITH A SET OF PROPOSED NEXT STEPS ALONG WITH ESTIMATED COSTS.
 WE WILL WORK CLOSELY WITH CONGRESSWOMAN SALINAS AND REPRESENTATIVE NERON TO SEEK THE NECESSARY FUNDS TO ADVANCE THE NEXT PHASE OF THE I-5 BOONE BRIDGE PROJECT. AS WE ALL KNOW, THIS IS A PRIORITY FOR WILSONVILLE THAT SHOULD ALSO BE A STATE AND FEDERAL PRIORITY.

A MEETING WITH PRINCIPALS OF METRO REGIONAL GOVERNMENT.

ON SATURDAY EVENING, FOLLOWING THE CITY COUNCIL RETREAT, YUMI AND I HAD THE HONOR OF ATTENDING THE 8TH ANNUAL RAMADAN POTLUCK GATHERING AT MERIDIAN CREEK MIDDLE SCHOOL.
