MAYOR'S BUSINESS [7:05 PM]

GOOD EVENING EVERYONE, I HOPE THAT EVERYONE HAD A WONDERFUL WEEKEND! SINCE OUR LAST CITY COUNCIL MEETING ON MAY 19, I WOULD LIKE TO UPDATE THE COUNCIL ON A NUMBER OF ITEMS.

FIRST, FOR THOSE WHO MAY NOT BE AWARE:

WILSONVILLE HAS JOINED A NATIONAL COALITION OF CITIES, COUNTIES, AND TRANSIT AGENCIES IN FILING A FEDERAL LAWSUIT AGAINST THE TRUMP ADMINISTRATION. AT STAKE ARE MILLIONS IN FEDERAL GRANTS THAT SUPPORT VITAL SERVICES — INCLUDING PUBLIC TRANSIT AND HOMELESSNESS ASSISTANCE — WHICH ARE NOW UNDER THREAT DUE TO UNLAWFUL CHANGES IMPOSED WITHOUT CONGRESSIONAL APPROVAL.

THE LAWSUIT, FILED IN U.S. DISTRICT COURT FOR THE WESTERN DISTRICT OF WASHINGTON, CHALLENGES NEW CONDITIONS ADDED BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AND THE DEPARTMENT OF TRANSPORTATION (DOT). THESE CHANGES REQUIRE LOCAL GOVERNMENTS TO MAKE LEGAL PROMISES THAT CONFLICT WITH

STATE AND LOCAL LAWS — PUTTING CITIES LIKE WILSONVILLE IN AN IMPOSSIBLE POSITION.

THE CORE ISSUE? FEDERAL AGENCIES CAN'T CHANGE THE RULES OF A GRANT PROGRAM MIDSTREAM WITHOUT CONGRESS SIGNING OFF. BUT THAT'S EXACTLY WHAT HAPPENED. NEW MANDATES — COVERING ISSUES LIKE IMMIGRATION ENFORCEMENT, HEALTHCARE, AND EQUITY INITIATIVES — WERE ADDED RETROACTIVELY TO GRANT AGREEMENTS, INCLUDING THOSE FUNDING OUR SMART TRANSIT SERVICES.

THESE CONDITIONS ARE NOT ONLY UNCONSTITUTIONAL, THEY WOULD UNDERMINE OUR ABILITY TO SERVE WILSONVILLE RESIDENTS. FOR EXAMPLE, COMPLYING WITH FEDERAL IMMIGRATION ENFORCEMENT REQUIREMENTS WOULD VIOLATE OREGON STATE LAW — LEAVING THE CITY LEGALLY EXPOSED ON BOTH SIDES. IF WE COMPLY, WE RISK STATE LAWSUITS. IF WE DON'T, WE COULD BE FORCED TO REPAY THREE TIMES THE AMOUNT OF OUR TRANSIT GRANTS. EITHER WAY, OUR COMMUNITY LOSES.

THAT'S WHY, ON MAY 21, WILSONVILLE STOOD UP — NOT JUST FOR OUR CITY, BUT FOR THE PRINCIPLE THAT LOCAL GOVERNMENTS SHOULD NOT BE COERCED INTO UNLAWFUL AGREEMENTS. THANKS TO OUR CITY ATTORNEY AMANDA GUILE-HIMAN AND HER TEAM, WE JOINED THIS LAWSUIT TO DEFEND THE RULE OF LAW, PROTECT OUR COMMUNITY SERVICES, AND ENSURE THAT LOCAL DECISIONS STAY LOCAL.

NEXT, I WOULD LIKE TO NOTE A FEW DATES OF OBSERVANCE THAT THE CITY'S DIVERSITY, EQUITY AND INCLUSION COMMITTEE HAS ADVANCED FOR THE MONTH OF JUNE.

### **Pride Month**

FIRST OFF, I WISH EVERYONE A HAPPY PRIDE MONTH.

PRIDE MONTH COMMEMORATES A LEGACY OF RESILIENCE AND PROGRESS OF CIVIL RIGHTS FOR ALL MEMBERS OF OUR COMMUNITY.

IN 1999, PRESIDENT BILL CLINTON MARKED THE ANNIVERSARY OF THE STONEWALL RIOTS AS GAY AND LESBIAN PRIDE MONTH.

LATER THIS DECLARATION WAS EXPANDED BY PRESIDENT BARACK OBAMA IN 2011 TO INCLUDE THE FULL SPECTRUM OF THE LESBIAN, GAY, BISEXUAL, TRANSGENDER, QUEER, INTERSEX, AND ASEXUAL INDIVIDUALS AND MANY OTHERS WHOM COLLECTIVELY ARE KNOWN ALSO AS THE LGBTQ+ COMMUNITY.

THE 'PRIDE' MOVEMENT EMBODIES SOLIDARITY, COLLECTIVE IDENTITY, AND RESISTANCE TO DISCRIMINATION AND VIOLENCE.

I WOULD ALSO LIKE TO NOTE THAT THIS SATURDAY, JUNE 7, FROM 2:00 TO 4:00 PM, THE CITY IS HOSTING A PRIDE CELEBRATION & MURAL RECEPTION AT TOWN CENTER PARK.

THIS FREE FAMILY-FRIENDLY EVENT IS AN OPPORTUNITY TO CELEBRATE PRIDE MONTH IN WILSONVILLE AND CONNECT WITH COMMUNITY.

ATTENDEES CAN PICK UP A NEW PRIDE PIN DESIGNED BY A WILSONVILLE HIGH SCHOOL STUDENT.

THE EVENT SHOWCASES A PRIDE MURAL DESIGNED AND PAINTED BY DAREN TODD ON THE WINDOWS OF THE PARKS AND REC.
ADMIN. BUILDING.

THE EVENT ALSO FEATURES SPEAKER ROBIN WILL, MUSIC PROVIDED BY DJ SM4SH; TIE DYING OF CLOTHES, FACE PAINTING, STORYTIME LED BY THE WILSONVILLE PUBLIC LIBRARY STAFF AND FOOD CARTS AVAILABLE FOR PURCHASE.

MISSING WHEN THE ROAD DIPPED WAY DOWN TO THE CREEK AND BACK UP.

WITH THE NEARBY FROG POND PRIMARY SCHOOL OPENING NEXT YEAR AND MERIDIAN CREEK MIDDLE SCHOOL RIGHT DOWN THE ROAD, ALONG WITH ALL OF THE NEW RESIDENTIAL DEVELOPMENTS IN THE FROG POND AREA, THE BOECKMAN CREEK BRIDGE WAS A NECESSARY INFRASTRUCTURE IMPROVEMENT.
