

- 9 voting members (6 original)


Accomplishments on Implementing Past Year's FY 2023/24 1/5-Year Action/Implementation Plan

- \$25K annually for nonprofit organizations
- Recipients included:

 - Wilsonville Rotary Foundation
 - Wilsonville STAGE

Public Art Program Policy and Guidelines

- Legitimizes program (first step)
- Provides transparency
- ACHC reviewed draft multiple times to recommend to Council
- Council adopted in November 2023

- Provided input to staff on RFQ
- Partnered with Wilsonville Skatepark Association

- Awarded project to Abigail Penfold (work completed in FY 25)









- Funded by Wilsonville Metro CEP




