ORDINANCE CORRECTING SCRIVENERS' ERRORS TO ORDINANCE 2025-11, AN ORDINANCE AMENDING SECTION 6.13.03 OF THE UNIFIED DEVELOPMENT ORDINANCE OF THE VILLAGE OF WINNEBAGO REGARDING FENCE REQUIREMENTS

WHEREAS, the Village of Winnebago Board of Trustees previously passed Ordinance No. 2025-11, entitled “An Ordinance Amending Section 6.13.03 of the Unified Development Ordinance of the Village of Winnebago Regarding Fence Requirements”; and

WHEREAS, Section I(10)(d) of said Ordinance references Ordinance No. 2018-14, titled “An Ordinance Certifying Results of the April 2, 2019 Liquor Referendum”; and

WHEREAS, it was recently discovered that such reference was a scrivener’s error, as the intended reference was to Ordinance No. 2018-13, entitled “An Ordinance Revoking, Replacing and Superseding Residential Landscape Ordinance (No. 00-06) and Amending Public Health Regulations Ordinance (No. 308)”; and

WHEREAS, it was never the intention of the Board of Trustees, in adopting Ordinance No. 2025-11, to reference Ordinance No. 2018-14, but rather to maintain the proper continuity and effect of the Village’s Unified Development Ordinance as amended by Ordinance No. 2018-13; and

WHEREAS, it is necessary to correct this clerical or scrivener’s error to ensure the legal accuracy and enforceability of Ordinance No. 2025-11.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Winnebago, Illinois, as follows:

SECTION I – CORRECTION OF SCRIVENER’S ERROR IN SECTION I(10)(d) OF ORDINANCE NO. 2025-11

Section I(10)(d) of Ordinance No. 2025-11 shall be and hereby is amended to correct the scrivener’s error contained therein by replacing the reference to “Ordinance No. 2018-14” with the correct reference to “Ordinance No. 2018-13”, An Ordinance Revoking, Replacing and Superseding Residential Landscape Ordinance (No. 00-06) and Amending Public Health Regulations Ordinance (No. 308).

SECTION II – CONTINUED EFFECTIVENESS OF OTHER PROVISIONS OF ORDINANCE

All other provisions of Ordinance No. 2025-11, as amended, shall remain in full force and effect.

SECTION III – EFFECTIVE DATE

This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as required by law.
