4. PUBLIC HEARING: Conduct a public hearing on a proposed economic development project to purchase land on major roads within the city of Wolfforth to promote new or expanded business development.

A public hearing is held by the governing body in order for the public to hear the facts and offer their opinions. The governing body is not obligated to engage in dialogue with those present.

The EDC is currently working on a land purchase contract along major roadways within the City of Wolfforth.

5. Consider and take appropriate action on request to limit vehicular traffic in Frenship Mesa on Halloween night

The Frenship Mesa Halloween event brings large crowds to this neighborhood. Last year, the Wolfforth Police Department blocked all roadways into Frenship Mesa, allowing only residents inside the neighborhood. To provide 10 officers to this event, the estimated budget is \$2,500.

Councilmember Worley questioned why City resources are being used for a private event in one neighborhood and is concerned that the estimated cost is too low. The Street Use Ordinance should be reviewed and changes made to address this type of neighborhood event.

Councilmember McDonald has concerns with the cost being beared by the City and with the event coinciding with a Frenship football game. This cost should not be spent on just one neighborhood alone.

Councilmember Stout stated that something will need to be done for this year as it is only a few days away.

Estimated attendance last year was 3500.

Councilmember Houck is concerned that the event is already organized and advertised for this year and something should be done for this year.

Staff agrees that a policy for this type of event is needed and will begin work on a draft policy to bring to the Council.

Councilmember Worley believes that this year, this police support is needed. Moving forward, a policy that puts the cost on the residents is needed.

Mayor Addington spoke that this event is going to happen regardless of this decision. He feels that this year, funding for Emergency Operations must be approved and a policy should be presented in the future to the Council to address this issue.

Tom Thiebauld - 316 Raider - Appreciates the City for their support and wants to be communicated with on any issues with the event. He is open to changes in the future in terms of funding etc.

Robert Garcia - 309 Longhorn - Frustrated with the traffic in the neighborhood and the vandalization that happens that night. Very difficult to get into the neighborhood as a resident. Need a better plan for residents to enter and exit the neighborhood.
