4 AN ORDINANCE AMENDING THE CITY OF WOODCREEK CODE OF
5 ORDINANCES CHAPTER 30, SECTION 30.16 (“MUNICIPAL SECRETARY”);
6 REPEALING SECTION 30.16 AND REPLACING IT.

7 WHEREAS, the City of Woodcreek (“City”) is a Texas General Law Municipality operating
8 under the laws of the State of Texas; and,

9 WHEREAS, the City Council hereby determines it advisable to amend the Code of Ordinances
10 as it relates to the office of the municipal secretary.

12 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
13 OF WOODCREEK, TEXAS, THAT:

15 **Section 1.** Findings. All of the above premises are hereby found to be true and correct
16 legislative and factual findings of the City Council and are hereby approved and incorporated into the
17 body of the Zoning Code as if copied in their entirety.

19 **Section 2.** Amending Code of Ordinances Section 30.16. That provisions in the Code of
20 Ordinances, Chapter 30, Section 30.16 are hereby repealed and replaced as provided for in the
21 attached Exhibit A.

22 **Section 3.** The repeal of any ordinance or part of ordinances effectuated by the enactment of
23 this Ordinance shall not be construed as abandoning any action now pending under or by virtue of such
24 ordinance or as discontinuing, abating, modifying, or altering any penalty accruing or to accrue, or as
25 affecting any rights of the City under any section or provisions of any ordinances at the time of passage
26 of this Ordinance.

27 **Section 4.** If any provision of this Ordinance is illegal, invalid, or unenforceable under present
28 or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid,
29 or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable
30 provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

31 **Section 5.** All Ordinances or parts thereof in conflict with this ordinance are hereby repealed as
32 to such conflict.

33 **Section 6.** This Ordinance shall be cumulative of all provisions of ordinances of the City except
34 where the provisions of the Ordinance are in direct conflict with the provisions of such ordinances, in
35 which event the conflicting provisions of such ordinances are hereby repealed.

37 **Section 7.** This Ordinance shall be construed and enforced in accordance with the laws of the
38 state of Texas and the United States of America.

40 **Section 8.** It is officially found, determined, and declared that the meeting at which this
41 Ordinance is adopted was open to the public as required and that public notice of the time, place, and

42 purpose of said meeting was given as required by the Texas Open Meetings Act, Chapter 551, Texas
43 Government Code, as amended.

45 **Section 9.** This Ordinance shall be in full force and effect after its final passage and approval
46 by the City Council, as duly attested by the Mayor and City Secretary, and any publication required by
47 law.
