# 1. Approval of Tree Board Meeting Minutes from May 24, 2022

# 2. Discuss and Take Appropriate Action on Proposed Updated Tree Ordinance

Vice-Chair Rasco made a motion to discuss and take appropriate action on the undated tree ordinance. The motion was seconded by Member McElroy.

After discussion, Vice-Chair Rasco revised the motion to pass the proposed updated tree ordinance with 3 suggestions. The suggestions are: i) that a certified arborist must be accreditted under TCIA, ii) that the cash-in-lieu payment be more than 20% and consider increasing it to discourage developers or encourage developers to be more creative in their

structural designs, and iii) that tree clearance be 8 feet at the property line and increase to 16 feet for the center of the street. The motion was seconded by Member McElroy.

# 3. Discuss and Take Appropriate Action on Arbor Day Event
