4 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODCREEK, TEXAS,**
5 **AMENDING THE CITY’S MASTER FEE SCHEDULE TO INCLUDE A FEE TO COVER THE**
6 **CITY’S COSTS FOR PROCESSING PETITIONS FOR THE RELEASE FROM THE CITY’S**
7 **EXTRA TERRITORIAL JURISDICTION (ETJ)**

9 **WHEREAS** Texas Local Government Code Chapter 42 authorizes a petition to filed with the City for
10 release from the City’s Extra Territorial Jurisdiction (ETJ); and
11

12 **WHEREAS** the petition must be signed by (1) more than 50 percent of the registered voters of the
13 area described by the petition as of the date of the preceding uniform election date; or
14 (2) a majority in value of the holders of title of land in the area described by the petition,
15 as indicated by the tax rolls of the applicable central appraisal district; and
16

17 **WHEREAS** the petition must include a map of the land to be released and describe the boundaries
18 of the land to be released by: (1) metes and bounds; or (2) lot and block number, if there
19 is a recorded map or plat; and
20

21 **WHEREAS** the City must engage professional engineering and legal services to assist in the review
22 and processing of the petitions; and
23

24 **WHEREAS** the verification of the petition requires the use City Staff and City recourse; and

26 **WHEREAS** the fee adopted pursuant to this resolution is hereby found and determined to be an
27 amount necessary for reimbursing the City is costs in processing a petition.

30 **NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOODCREEK, TEXAS, THAT:**

32 **MASTER FEE SCHEDULE AMENDED:** The City Council hereby amends the City’s Master Fee Schedule by adopting
33 a fee for processing petitions for release from the ETJ in the amount of six hundred fifty dollars and zero cents
34 (\$650.00).
