**A RESOLUTION SETTING THE STIPEND FOR
WEST BURLINGTON VOLUNTEER FIREFIGHTERS**

BE IT RESOLVED, by the City Council of the City of West Burlington, Iowa, the Volunteer/Paid-on-Call Firefighters shall receive a stipend effective with the July 2021 calls and stipends payable in August 2021 through June calls and stipends payable July 2022. The Finance Officer is authorized to issue warrants, less legally required or authorized deductions and to make such contribution to IPERS and Social Security or other purposes as required by law or authorized of the City Council, all subject to audit and review by the City Council.

The total fiscal year distribution budgeted for City stipends is \$53,203 and will be distributed on a monthly basis of \$4,433.58 or until the funds are expended or the time period ends. (*These amounts do not include budgeted FICA, IPERS and Workman's Compensation amounts).

Stipends will be distributed based on actual performance in categories of alarms for members who have completed initial training requirements.

Members will be compensated for attendance of monthly department training and meetings at a rate of \$25 per meeting.

Meeting Compensation \$25 per meeting, per member

Members will be compensated for station time, public education events and additional training beyond scheduled monthly training.

0-5 hours - \$0.00
5.01-15 hours – \$20.00
15.01-25 hours – \$40.00
25.01 or more hours - \$75.00


No member shall exceed \$990 per month in total stipend, meeting and station time combined.
