Please don't rezone for apartments/town homes at Park and Country Club. I know I don't technically get a vote in this, but I'm letting you know that if I could vote, I would vote against rezoning.

I imagine that I'm in the same boat as a lot of the home owners around here. I specifically purchased my home in Birmingham Farms because we liked the location and the surrounding (walking distance) area. One of the data sheets our realtor gave us when we bought the home included the zoning restrictions for the surrounding area within walking distance. This weighed HEAVILY on our reasoning for buying our home. If the City Counsel or the Zoning Board rezones the areas around us, I will transition from a happy quiet citizen of Wylie, to being a grouchy outspoken one.

I'm already saddened by the zoning board's total lack of effort put into getting community feedback about this decision. They issued far fewer notices than they should have, and didn't get ANY feedback, which they interpreted as approval to proceed. I interpret that as a very poorly executed survey, and a sign that our zoning board is run by people that are satisfied to meet the absolute minimum requirements and move on. This isn't the kind of people I want representing me, or making zoning decisions for my city. I feel obligated to advocate for a change in representation within our Zoning board members.

I hope that the City Council votes to deny this zoning change being that the Zoning Board approved. If this vote goes through, I'd just take it as a sign that I no longer see eye to eye with my city council representatives either. And my sign that I apparently supported the wrong representatives and need to be more involved in the Wylie elections and work harder to get and keep leadership that we see eye to eye with.
