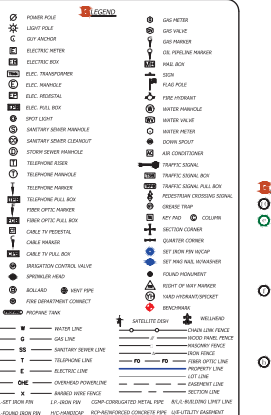
GENERAL NOTES

- 9 Pursuant to Table A Item 6, Said described property (*i.e.*, by graphical symbol) only located within an area having a Zone Designation "X" established by FEMA, on Floor Plan No. H-08703-C-001, attached hereto as Appendix B.
- 10 The Property has direct access to West F.R. 544 and Houder Road, both being a dedicated public road.
- 11 Pursuant to Table A item 6, The total number of impervious parking spaces on the subject property is 0, including a designated handicap space.
- 12 Pursuant to Table A item 16, There is no observed evidence of current earth moving work or utility installation occurring at the site.
- 13 Pursuant to Table A item 17, There are no proposed changes in street right of way to best of my knowledge. There is no observed evidence of recent street or sidewalk construction or repairs.
- 14 There is no observed evidence of site use as a solid waste dump, pump or sanitary landfill.
- 15 A assumed bearing from North 32° 30' 21" West as the West line of the subject property per Texas State Plane Grid Texas Survey was used as the basis of bearing for all survey measurements.
- 16 All units of measurement are US Survey Feet (NGD).

10: This ground survey was performed at the 85% percent confidence level to meet Federal Geographic Data Committee Standards; that this survey was performed to meet the requirements for a topographic/planimetric survey. This survey substantially complies with the current Texas Society of Professional Surveyors Manual of Practice requirements for a Category 6, Condition 1, Topographic Survey. The original data was obtained on 08/20/2025; that the survey was completed on September 10, 2025; that contours shown as [broken lines] may not meet the stated standard; and all coordinates are based on Texas State Plane Grid Texas North Central NAD 83 and realization elevations are based on NAVD 88.
