

## WYLIE-KREYMER (HUGHES) CEMETERY ASSOCIATION

The following is a summary of rules and regulations adopted by the Board of Directors of the Wylie-Kreymer (Hughes) Cemetery Association.

Only markers of the flat or ground level type are to be placed in the new section of the cemetery. No marker shall be placed without first notifying a representative of the Cemetery Association at Allen Funeral Home, Wylie, Texas.

No grave shall be opened without first obtaining a permit from Allen Funeral Home, Inc. A steel box or better is required for all interments in all of the Wylie-Kreymer (Hughes) Cemetery.

No curbs, formed or loose rock, stone, gravel, marble, concrete or other materials shall be placed on or near the grave sites.

In order to properly maintain lawns, it is necessary that all grave decorations be limited to placement of arrangements in approved subsurface level cemetery vases at places of interment. Only one arrangement per grave is permitted during mowing season (March 1-November 1). If a ground level vase has not been yet placed at the interment location, information on approved designs may be obtained at Allen Funeral Home, Inc., Wylie, Texas.

Placement of items at the grave site is prohibited. This includes but is not limited to ANY glass object, potted plants, benches, statues, shepherd crooks, stuffed animals, toys, etc. Digging holes in the ground or placing rods or brackets to support top-heavy pots and containers at places of interment is not permitted at any time. Placement of flower arrangements, wreaths, pot plants and baskets are permitted only on Valentine's Day, Easter, Mother's Day, Father's Day, Memorial Day, Thanksgiving, Christmas and Birthdays. Placement may be made during the week before and may be removed and disposed of by the cemetery on the eighth day following the occasion.

There may be times when dirt will be placed on adjoining lots when opening another grave you are reminded that when you need a grave opened, the dirt from your grave will be placed on someone else's lot. The dirt will be moved at the earliest possible time. If there has been rain, dirt may not be moved until it has dried sufficiently as not to cause damage to lots in the area.

It is the Cemetery Associations obligation for year round maintenance of the lawns and the trimming of the grass. Planting of trees, shrubs, bushes, flowers or ground cover is prohibited inside cemetery grounds.

The Wylie-Kreymer (Hughes) Cemetery Association is not responsible for personal property, acts of vandalism, or containers placed at any interment location.

The Wylie-Kreymer (Hughes) Cemetery Association assumes the care of the cemetery through income produced from donations and the sale of lots. The above rules and restrictions are adopted in order to provide uniform care for all lots at the most reasonable expense. In order for this arrangement to be a workable one, the Association must have the cooperation and support of all concerned.
