Additionally, the structure encroaches on a telephone utility easement established by the 2000 plat. The foundation and framing were constructed without proper approvals. A survey should have been conducted, alerting the owners that the structure could not be erected without City of Wylie approval. If permits had been applied for by the owner or contractor, these issues would have been identified before construction began.
