# 3. RECOGNITIONS/PERSONS TO ADDRESS THE MAYOR & COUNCIL

He expressed his opposition to the abandonment and relocation of an existing access servitude, as implied in the approved plat of survey, File No. 2023-00011602. He stated that his presence is to document issues associated with plat and guarantee his servitude rights within the 2-year statue limitation. He requested that the City of Youngsville record a correction pertaining to the implied abandonment and relocation of an existing access servitude.

The letter should advise the property owner that the "proposed" language on the plat is not officially recognized as the servitude agreement was not formally abandoned.
