

WATER AND SEWER AGREEMENT

BY AND BETWEEN

CITY OF YOUNGSVILLE and

ST. MARTIN PARISH GOVERNMENT

This Water and Sewer Agreement is made and entered into by and between City of Youngsville, a political subdivision of the State of Louisiana, Parish of Lafayette (“YOUNGSVILLE”) and St. Martin Parish Government, a political subdivision of the State of Louisiana (“ST. MARTIN”) for the purpose of establishing water supply service and sewage service to certain lots that partially or completely lie within the jurisdictional limits of St. Martin Parish.

WHEREAS, that certain subdivision known as Metairie Place, Phase 3 on the official plat recorded at Inst. No. 577106, Book 1927, Page 452 in the official records for St. Martin Parish, Louisiana contains within it certain lots which are divided by the parish boundary line between Lafayette Parish and St. Martin Parish;

WHEREAS, Lafayette City-Parish Consolidated Government (“LCG”) and YOUNGSVILLE established a Wholesale Water Agreement on December 24, 1998, recorded as Act. No. 98-055657 in the records for Lafayette Parish, Louisiana in order to provide that YOUNGSVILLE might supply water services to all customers within the corporate limits;

WHEREAS, LCG and YOUNGSVILLE amended said Wholesale Water Agreement on June 25, 2024 to allow YOUNGSVILLE to supply water services outside of its corporate limits, including to the lots in Metairie Place Subdivision that might lie outside YOUNGSVILLE’S limits;

WHEREAS, ST. MARTIN, in the interest of practicality and efficiency, wishes to allow YOUNGSVILLE to operate water supplies in order to service those lots that partially or completely lie within the jurisdictional limits of ST. MARTIN, namely Lots 38-49, Metairie Place, Phase 3, St. Martin Parish, Louisiana (“LOTS”);

WHEREAS, YOUNGSVILLE additionally agrees to provide sewage services to LOTS and ST. MARTIN agrees to permit YOUNGSVILLE to operate its sewer services within the St. Martin Parish limits for the purpose of serving the LOTS.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereby agree that ST. MARTIN shall allow and YOUNGSVILLE shall be permitted to provide water and sewer services to the LOTS within the jurisdictional limits of St. Martin Parish, Louisiana.

THUS DONE AND SIGNED by authority granted as per attached resolutions of the above respective governmental bodies through the undersigned duly authorized officers.
