

SRO COOPERATIVE ENDEAVOR AGREEMENT – ADDENDUM FOR THIRD SRO

The **CITY OF YOUNGSVILLE** (“City”) and **LAFAYETTE CHARTER FOUNDATION, INC** (“Foundation”) entered into a Cooperative Endeavor Agreement (the “Agreement”) effective June 1, 2023, which provided for School Resource Officers at Acadiana Renaissance Charter Academy.

By this Addendum, the parties herein wish to extend the Agreement for an additional school year and expand the Agreement to include an additional School Resource Officer bringing the total to three (3) officers:

1. **CONTRACT EXTENSION:** The initial term of the Agreement expires on August 1, 2024. The parties hereto wish to renew the Agreement for an additional one (1) year term commencing on August 1, 2024.
2. **ADDITION OF THIRD SRO:** The original Agreement provides for two (2) SROs at a cost of \$55,000.00 per SRO. By this Addendum, it is agreed that the City shall provide one (1) additional school resource officer for the 2024-2025 school year for a total of three (3) SROs on the Acadiana Renaissance Charter Academy campuses. This third SRO will be paid the same rate of \$55,000 per year, which shall be paid in ten (10) installments of \$5,500 from August through May, payable on the first of each month.
3. **EFFECTIVE DATE:** This Addendum shall be effective on August 1, 2024.
4. The Foundation shall provide each SRO the same meal being served in the school’s cafeteria without any cost to the SRO.
5. **COUNTERPARTS:** This Addendum may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
6. **ENTIRE AGREEMENT:** This Addendum and the Agreement constitute the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, whether written or oral, concerning such subject matter.

All other provisions of the Cooperative Endeavor Agreement shall remain in full force and effect between the parties except as amended herein.
