

COMMON AREA/DRAINAGE SERVITUDE

LEGAL DESCRIPTION

A CERTAIN PARCEL OF LAND BEING 8.214 ACRES SITUATED IN SECTION 12, TOWNSHIP-11-SOUTH, RANGE-4-EAST, CITY OF YOUNGSVILLE, LAFAYETTE PARISH, LOUISIANA FURTHER DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTH WESTERN CORNER OF PARCEL NUMBER 6167646 OWNED BY RED APPLE AT LAFAYETTE SOUTH II LLC SAID POINT BEING THE POINT OF COMMENCEMENT (P.O.C.), THENCE PROCEED ALONG THE NORTHERN BOUNDARY OF SAVOY ROAD WITH A BEARING OF SOUTH 89°37'43" WEST FOR A DISTANCE OF 905.53 FEET TO A POINT, SAID POINT BEING THE POINT OF BEGINNING (P.O.B.);
